ORDINANCE NO. 232

**AN ORDINANCE OF THE TOWN OF CARNEGIE, OKLAHOMA,
AMENDING SUBSECTIONS 1, 2 AND 3 OF SECTION 16-35,
ARTICLE 4, CHAPTER 16 OF THE "CARNEGIE CODE OF ORDINANCES"
AND DECLARING AN EMERGENCY**

NOW, THEREFORE, BE IT ORDAINED BY THE Board of Trustees of Carnegie, Oklahoma:

SECTION 1.

Subsections 1, 2 and 3, Section 16-35, Article 4, Chapter 16 of the "Carnegie Code of Ordinances" shall be amended to read as follows:

1. Single family dwelling units
mobile homes and trailers, inside the
Town limits \$15.00 per month

2. Single family dwelling units,
mobile home and trailers, outside the
Town limits \$17.00 per month

3. Other rate categories as follows:
 - (1) Bring trash in \$17.00 per month
 - (2) Out of Town with Dumpster \$42.00 per month
 - (3) Business without Dumpster \$17.00 per month
 - (4) Business with Dumpster 1X \$24.00 per month
 - (5) Business with Dumpster 2X \$38.00 per month
 - (6) Business with Dumpster 3X \$51.00 per month
 - (7) Business with Dumpster 4X \$64.00 per month
 - (8) Business with Dumpster 5X \$77.00 per month
 - (9) Business with 2 Dumpsters 1X \$36.00 per month
 - (10) Business with 2 Dumpsters 2X \$58.00 per month
 - (11) Business with 2 Dumpsters 3X \$78.00 per month
 - (12) Business with 2 Dumpsters 4X \$98.00 per month
 - (13) Business with 2 Dumpsters 5X \$118.00 per month
 - (14) Business with 3 Dumpsters 1X \$48.00 per month
 - (15) Business with 3 Dumpsters 2X \$78.00 per month
 - (16) Business with 3 Dumpsters 3X \$105.00 per month
